I am directed to convey the approval of Competent Authority for conduct of National Coaching Camp for Senior Men & Women Para Rowing Coaching Camp at ARN, Pune from 15 Jan 2020 to 31 Mar 2021 (76 days) for 7 Rowers 1 coaches & 3 support Staff to prepare rowers for the forthcoming FISA & Asian Paralympic Qualification Championships, 2021.

5. Any inclusion/deletion of national campers should not be entertained without prior approval of the TOPS POD Division.
6. No unauthorized absence from national camps would be allowed. Based on the recommendations of an officer authorized by RFI leave of absence would be allowed only by prior permission of the Head of Institute where coaching camp is organized. Unauthorized absence during dope testing call would be presumed as deliberate leading to consequent action by RFI.
7. On conclusion of the national coaching camp, National/Coach/Coach Incharge shall submit a report on coaching camp through the Director of concerned Regional Director within 10 days to the Director, TOPS-POD. The Regional Director shall also submit expenditure statement for the camp within a month to the ED, Finance with a copy to the TOPS-POD Division.
8. Please ensure that the SOP issued by SAI and MHA & State Government guidelines for COVID-19 are strictly adhered to. **The undertaking of all athletes may be taken by ARN, Pune in accordance with SAI SOP prior commencement of sports activity. In addition, ARN, Pune appoint a Hygiene Officer for the group of Rowing Campers.**
9. List of athletes reported for the sports activity should be forwarded to TOPS-POD Division on the 3<sup>rd</sup> day from the commencement of the camp.
10. **Quarantine:** The athletes joining at ARN, Pune would have to undergo the mandatory quarantine as envisaged by the laid down by ARN Pune/State Govt. norms.
11. The expenditure will be debited under the head "General Assistance for Holding Coaching Camp".
12. All bills pertaining to the camp shall be submitted **within 21 days** of completion of the camp.
13. Scientific Support shall also be extended to the athletes on request.
14. The monitoring of attendance on daily basis shall be maintained
