- 2. As per the provisions of the scheme, the admissible assistance for air passage, Boarding/Lodging etc. would be provided to the above team members.
- 3. Section 9 of FC (R) Act, 1976, provides inter-alia that no Member of a legislature, office bearers of a political party, Judge, Government Servant or employee of any Corporation shall accept any foreign hospitality without prior permission of the Central Government. In case, any team member is covered under the above Act, he/she should obtain the prior permission from the Ministry of Home Affairs before his/her departure to Tokyo, Japan.
- 4. As regards foreign exchange required for above participation on the federation is requested to approach authorized dealers for getting foreign exchange in view of RBI circular No.41 A.D (M.A.series) dated 25.1.97.
- 5. Such of the team–member who might be central Government Servants are too treated as on duty (which include deputation abroad) in respect of the participation by the Department Personal & Training O.M.No. 6/1/85-Est. (pay-1) dated 30.1.1989. The federation should inform their employing Department /Office accordingly.
- 6. It is requested that Indian High Commission/Embassy of Tokyo, Japan and organizers of the event may please be informed of travel plans and itinerary of the delegation for participation in above event. The team members may be advised to call on Mission for exchange of view.
- 7. A report on the visit of the team along with its performance/achievement in the above event may please be sent to this Ministry/SAI within 7 days of the return of the team to India along with some action photographs, if possible.
- 8. Before departure, a report on dope test of the team members may please be obtained from DG, NADA, New Delhi.
