The polling commenced at 11:00 am on 25.02.2024 and concluded at 2:00 pm. The polled ballot papers were duly sealed in the ballot box in the presence of the contesting candidates and were kept in my custody till further orders of the Delhi Hon'ble Court.

By orders dated 02.07.2025 the Hon'ble High Court of Delhi had permitted declaration of results within 10 days. Accordingly, vide **Proceeding No.8**/WB Returning Officer **dated 4.7.2025** it was notified and published to all concerned and the candidates through the RFI website that the counting of votes and announcing of results will be held on 11.07.2025 at 11.30 am at Sports Authority of Telangana Academy, Hussainsagar Lake, Hyderabad.

On the said date i.e, 11.07.2025 the counting of votes and declaration of results were taken up in the presence of 8 candidates who attended and also in the presence of the IOA Observer. After completion of the counting of votes, results were announced and declared to all the posts and was published in the prescribed Form 14 and 15 respectively, duly sending it to Rowing Federation of India, for publication in the website and also to report the same to the Hon'ble High Court of Delhi towards compliance of the Hon'ble Court's Order dt.02.07.2025.
